Youlgrave Parish Council manages Alport Lane Playing Fields on behalf of Fields in Trust and Holywell Lane Public Toilet Block on behalf of the charity. The charity holds the assets and all funding and management is provided at cost to Youlgrave Parish Council which offsets any income directly attributable to the assets against running costs and provides the balance of funds from the precept to ensure the charity does not make a loss.

Provision of a playing field and recreation ground along with amenities for public use.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit) The Parish Council maintains and renews the assets as well as enhancing this by provision of specific items for play and exercise from its funds to give added value to the public use. The field areas are open year round and toilet blocks for as much of the year as council deems safe from the extremes of weather or closure for essential maintenance. Regular inspections of the facilities are carried out and Council encourages team sports by provision of dedicated areas for football and cricket with a pavilion available for team use. It also leases an area to the Bowls Club for their pavilion and green.

Section D	Achievements and performance
Summary of the main achievements of the charity during the year	 Queen Elizabeth II Alport Lane Playing Fields This area is used by the Football, Cricket and Bowls Clubs and by Youlgrave School and the Youlgrave Carnival on an organised basis; as well as being used throughout the seasons as a safe play area for village children and visitors alike. Improvements have been carried out to enhance the experience of users of this valuable facility. Provision by Council of Air Fitness equipment – 3 sets of 3 pieces of varying difficulty placed around the field with the milder exertion pieces near the entrance to encourage all age participation. Remodelling of the BMX trail below the children's play area to incorporate practical needs after the first year of use. Holywell Lane Toilet Block The costs continue to benefit from our cleaner's only charging for the winter months (having included the block into the existing charge for the summer contract (cleaning 3) and donations are increasing.

The main sources of income are two honesty boxes, a DDDC mowing grant and rents from club use. The Parish Council pays for any shortfall to cover the costs hence a balance of income and expenditure annually. On this occasion due to an accounting practice change by DDDC we have received last year and this year's mowing grant in the same financial year. This means that the charity shows a profit for the year and has not needed Council making up the shortfall. However as the post year events show the roof being replaced at Holywell Lane and the income will now be claimed in the current year for as long as the grant continues so this stand alone situation will not be repeated.
