2114 To receive apologies for absence

Cllr Andrew McCloy sent his apologies. Cllr Moore apologised for a meeting clash and left half way through item 2123.

2117 Public Speaking

County Councillor Simon Spencer and PC Hyde sent their apologies. Our County Councillor had attended last week's Finance meeting using the date from the last agenda which was subsequently changed. Councillors had thanked him for his persistence in getting the lower church steps handrail to planning stage.

- a) Public none present. It was noted that the urgent local need from last month has accepted a property in Bakewell.
- b) The District Councillor reported that the petition to support community transport that needed at least 7500 signatures to enable County Councillors to revisit the funding cuts had received 15000 to date.

Comments returned due to deadlines:

NP/DDD/1015/0920 – Hopton Tower The Old Hall 1.5m boundary dry stone wall – no objections

NP/DDD/1015/0936 – Church Steps Handrail – Council fully supports this application which it had been asking to be installed for three and a half years. This is an essential requirement for this stepped entrance to allow the less able access to and from the churchyard along the public footpath. We fervently wish to see this passed and Derbyshire County Council to install prior to the onset of winter.

2121 Footpaths and Highways and related issues

Still no response from Trading Standards on reported HGV vehicles or Highways on moving the 7.5 Tonne limits.

Rights of Way has inspected Footpath 24 at the parish boundary where it crosses Bleakley Dyke and will budget repairs for the next financial year.

No response has been received regarding the deterioration of the Bradford Dale footpaths making them extremely difficult for wheelchair and pushchair access.

Alport Lane beyond Alport has up to today seen no work to clear the footpaths.

The Conksbury Lane sign is under negotiations for replacement.

Grit will be available for sale from Youlgrave Garage again this year.

Lighting concerns over a dark spot on Bradford where a light was knocked down and not replace some years ago will be forwarded as will a request to move the light on Church Street near the Post office to opposite Barnes Lane junction.

A request for a free dispenser for dog mess bags was felt not to be appropriate at this time due to the number of bags being slung into hedges and gardens and should only be considered if DDDC increases its network of waste bins.

2122 Reports from Village Organisations -

S&C Hall – work ongoing

Village Hall – is buying a new industrial size cooker to cater for larger numbers.

Reading Room – is fortunate to be supported by receiving handed on items and the three day sale did very well raising £550

CLT – councillors have been invited to the Building Award event at 11am on 28th November. A sub-committee is meeting this evening with Winster to fact-find how they run their village shop as we will shortly be down to one and the CLT wants to look at putting contingencies in place should there be no interest when it eventually comes for sale.

Waterworks – seasonal weather delays are hampering the new works but otherwise the company is running well. In response to a comment about river levels it was noted that it's Severn Trent not Youlgrave Water pipes that are being questioned for losses.

2123 Report of the Clerk / update on: -

a) Playing Field and Village asset matters

Playing Fields – the toilet blocks are closed and water off. The fridge has been replaced by the cricket club and the clerk will arrange for Pat Testing.

A request was received for assistance with the commemorative tree and will be responded to.

Holywell Lane Toilet block has suffered a second arson attack with the toilet rolls being set light to in the Ladies this time and cigarettes being stubbed out on the doors – CR49659/15 – Police and our interest will be noted for the Bugle. It was noted that CCTV might be desirable in this area at some point.

- b) Allotments all plots let and a waiting list of 3 currently. A complaint has been received regarding tipping of cuttings into the dale which can be dangerous for the cattle grazing and an article is going in the next Bugle.
- c) Project costing progress DDDC Grant the application for a licence to install a bench at Fountain Square is in progress 4 weeks. Fountain Square bench on

removable posts – the makers of the matching bench nearby have declined to quote. It was decided to source a bench locally to a similar style with arms.

Floodlighting for the MUGA. No response yet from the football club. The clerk has passed on details of DDDC sport club grants.

Westcroft residents have asked for a grit bin half way along. The clerk will chase DCC to provide one for free and obtain from Long Rake if none are available.

d) Tree Planting Ceremony report

The event was a success with the High Sheriff planting the tree and cutting the ribbon for the BMX trail and Hope Construction Materials attending with their banner and all being photgraphed for the Derbyshire Times/Matlock Mercury and Buxton Advertiser – including a video for the online versions.

The clerk has circulated photographs and Cllr Elliott supplied a report to Daran Murray at Hope Construction Materials.

Council thanked Cllr Elliott for his hours organising the project and for hosting the ceremony.

e) Christmas Tree

A Norwegian Spruce is to be sourced at 6' rooted and planted a 9' cut tree ordered each year until it is of sufficient height to be used.
