1866 Planning decisions/applications received since last meeting. Planning related matters

Decisions received: none

Comments returned: none

Applications for discussion:

NP/DDD/0414/0421 - Honeysuckle Cottage, Main St - alterations to dwelling Resolved to approve of this application as an obvious improvement to the building.

NP/DDD/0414/0419 - The Chase, Coldwell End - Single Earth sheltered dwelling on derelict agricultural land to the West of Youlgrave

By a majority of Four votes for, Two against and One abstention Youlgrave Parish Council supports wholeheartedly this application.

Council agreed that this was a groundbreaking, innovative and imaginative design that will tidy up the eyesore at this entrance to the village and provide a dwelling for a local family.

A motion to refuse on the grounds that the site lies outside the planning line was defeated by a vote of Two votes for, Four against and One abstention.

A request to record the voting had been received at the commencement of this item and those for the motion were Cllrs Clark, Goodwin Moore and Shimwell, against Cllrs Elliott and Wragg and abstention Cllr Wardle.

1867 Footpaths and Highways and related issues

Clerk to report to DCC: again -reminders for churchyard public footpath 17 lower handrail SBS903179, resurfacing at Bankside and Grove Place to Westcroft footpath and the 24 hour no stopping opposite New Road on Alport Lane sign. The problem of traffic parking up to the corner of Bradford / Brassington Close junction is causing cars to pull to the middle of the road for line of sight. Highways are to be invited to visit to see if a workable solution can be found. Ruts in the road down Bradford are worsening causing pedestrian hazards. Wednesday morning is becoming a regular parking infringement problem at Alport Lane Playing Fields.

1868 Reports from Village Organisations –

S&C Hall – nothing to report

Village Hall – nothing to report

Reading Room – The Folk Club has moved from the Bulls Head owing to the uncertainties of another landlord departing to find a Friday home – the first event proved very successful.

CLT - the committee have been receiving name suggestions for the new road.

Water Board – has moved to the Reading Room for its meetings. The subject of converted buildings on existing properties becoming holiday cottages is being investigated as they should be charged as a separate unit.

1869 Report of the Clerk on: -

a) Playing Field and asset matters –

Pavilion Door quote was agreed too expensive and the clerk awaiting other quotes. He door has been freed off for now by the cricket club joiner who has also rehanged the toilet door temporarily.

Following a request for a picnic bench by the toddler/junior area Council is to relocate the existing table by the wildflower area. Clerk to check with Ian Weatherly that current usage is minimal where sited.

The Royal Oak is now being looked after by Councillor Elliott.

Noticeboard – the notice is up and if no complaints are received permission will be granted in early June. A 7" core bit will need to be hired to insert the post holders into the concrete.

Holywell Lane Toilet Block – The plumber reports rot in the roof and the water meter is now installed. The clerk and Councillor Goodwin will investigate while working out a Spec for repairs.

- b) Allotments The annual skip will be booked for the weekend of 6th June.
- c) Website our editors are now accessing the site and passwords issued to allow halls to enter diary items. An article will be placed in the Bugle to inform parishioners who the editors are and who to contact with details / articles etc.
- d) Defibrillators

The WI have donated £260. It was agreed that a thank you article naming all non-anonymous donations be placed in the Bugle as soon as the Farmyard box is live.

The second is on 27th May at 7.30pm in the Village Hall. Further sessions will be arranged as required.

It was agreed to call a photo shoot at the Alport Kiosk at 10am tomorrow to publicise the four units further afield.
