2533 Report of the Clerk / update on: -

a) Charity 520537 assets:

Playing Fields – ALPF – pavilion now on electric smart meter. The showers are only occasionally used and heating the tank in case was noted to be wasteful by the plumber. A replacement with 2 or 3 electric showers needs costing.

HLTB – DDDC no longer to supply sanitary towel bins – informed us it was costing them £85 per annum. Clerk to source replacements.

b) CE Toilets – broken seat needs replacement – one old spare is available for now.

Allotments – 2 vacant plots – all others renewed

Allotment inspection 5th June 7pm will also look at a village gateway. The annual skip has been ordered for 1st June.
