Youlgrave Parish Council manages Alport Lane Playing Fields on behalf of Fields in Trust and Holywell Lane Public Toilet Block on behalf of the charity. The charity holds the assets and all funding and management is provided at cost to Youlgrave Parish Council which offsets any income directly attributable to the assets against running costs and provides the balance of funds from the precept to ensure the charity does not make a loss.

Provision of a playing field and recreation ground along with amenities for public use.

The field areas are open year round and toilet blocks for as much of the year as council deems safe from the extremes of weather or closure for essential maintenance. Regular inspections of the facilities are carried out and Council encourages team sports by provision of dedicated areas for football and cricket with a pavilion available for team use. It also leases an area to the Bowls Club for their pavilion and green.
